## Registration Process

1. Complete the Team Registration form (Deadline May 31,2019)
2. Each player completes the Adult Registration Form or the Youth Registration Form as well as the safety waivers.
3. Submit all forms in-person at the Southland Mall admin office between 9:00AM-12:00PM or 1:00-5:00PM, Monday- Friday.
4. Registration forms must include cheque payable to "SBLP Southland Mall Inc." for \$199. No cash accepted.
5. 8 teams per division. **First come, first serve.**

## Guidelines & Rules

- 3-8 players per team plus 1 goalie
- Games will be 3-on-3 style play
- Players must provide their own hockey stick and wear hockey gloves.
- Players under 18 years of age are required to wear a hockey helmet with full face protection (cage).
- Teams are required to provide their own goalie gear which is to include chest protector, pads and full caged goalie mask. If goalie gear unavailable, please let us know upon registering for the possibility of borrowing shared equipment.
- Each team will play a minimum of 2 games
- Games will consist of (1) 30-minute period. No breaks.
- Slap shots are not permitted, and sticks are not to go above the waist for any reason. Additional rules will be reviewed with each team at the tournament.
- In the event of a penalty or high sticking, the opposing team will receive one penalty shot, at the referee's discretion.
